### Unique Verification Technology

The 4verify management system has moved away from the old, traditional barcode scanners, and into smart devices. These devices are already familiar to the youth and as such, are quicker and easier for your company to use and understand.

created specifically to verify existing asset registers or to create a new register from scratch.



### 4verify has features that are not available on traditional systems including:

- Ability to instantly create asset inventories, electronically signed by the custodian.
- Email copies of electronically signed inventories to the custodian, automatically.
- Provide you with accurate fair market values of your assets (AG approved).
- View verification discrepancies on the device as they occur.
- Easily take pictures of every asset (without a clunky camera).
- Synchronise information instantly, regardless of your location, always connected.
- Instantly report on discrepancies.
- Dashboard reports on overall verification status.
- Run multiple devices in multiple locations while maintaining head office control.

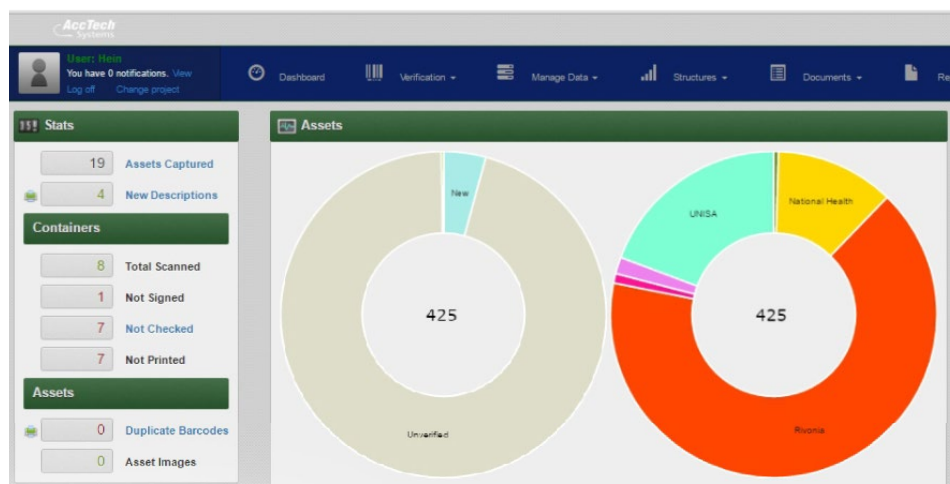
# REPORTING ABILITIES

The biggest part of the verification is the ability that you now have to monitor your progress on a real time basis on the project status. You can use the dashboard to monitor your asset verification progress as it happens.

# USER WEB INTERFACE

Being a web-based solution, the user can access the administration module through a web browser. All users are assigned a role and based on their security level, they are allowed access to various functions.

Users with the necessary access can see the progress of a verification directly from the dashboard. Interactive drill-downs make it easy to enquire on the detail of any specified area on the verification.



## Common indicators you need to include:

- Assets that are fully verified and compliant
- Assets on the ground, but not on the asset register
- Assets on the register, but not verified
- Assets in poor condition that need repairs
- Assets that are broken
- Assets that are redundant
- Assets incorrectly described / classified
- Investigations that need to be performed

## Mobile interface

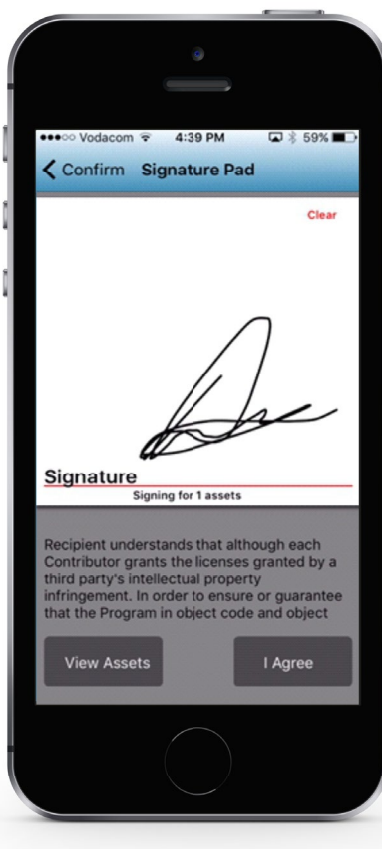
From the device interface it is easy to see the progress of any verification. Each user has login security, allowing them access only to their projects.

Any verification done is logged against the user's name and is time stamped so that the latest information is always updated.

## Compatibility with other systems

## Owner signs off on device

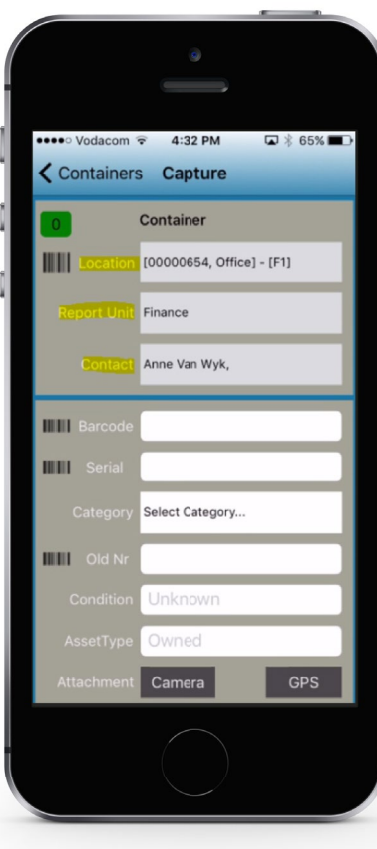


## Owners are made responsible for their assets

Once an owner's assets have been scanned, the owner can confirm and sign off the asset list on the mobile device.

It means that any discrepancies are handled on the spot and the owner knows in advance what their responsibility is.

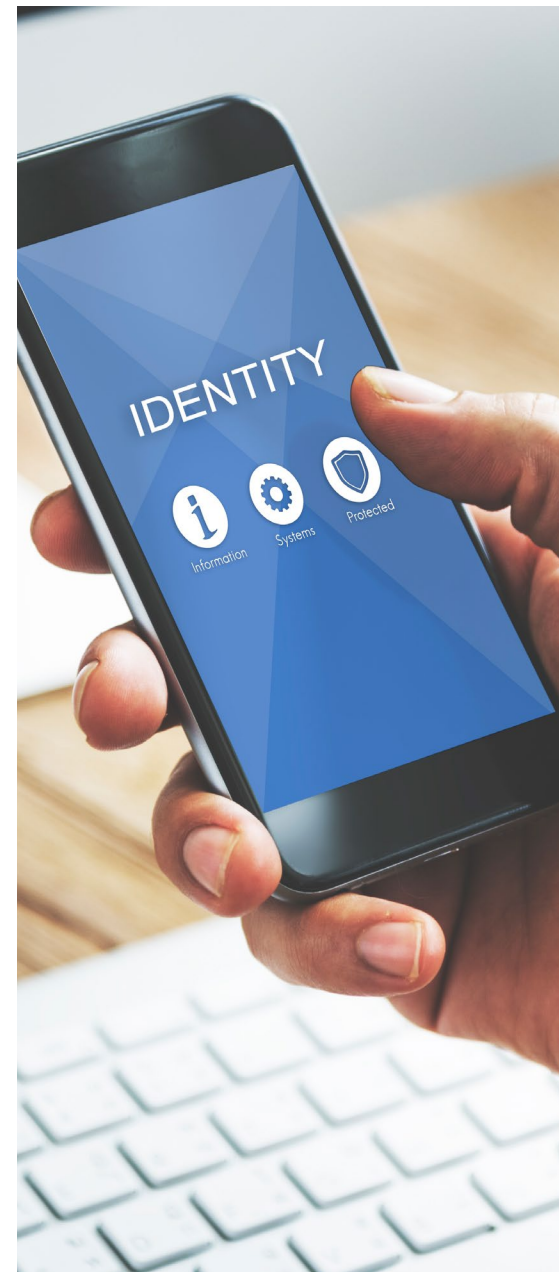
The system can produce a final sign off report that is automatically mailed to the owner, so that they can receive the full details of which assets they are responsible for.



## Unique assets identification

With the availability of all the information on the scanner, each asset can be uniquely identified and will allow the company to pinpoint where the asset is and who is responsible.

Each asset can have a barcode, serial number, category, description, responsible person, location and cost centre. The camera can be used to take pictures and it can even capture the GPS coordinates, for those out of office assets.

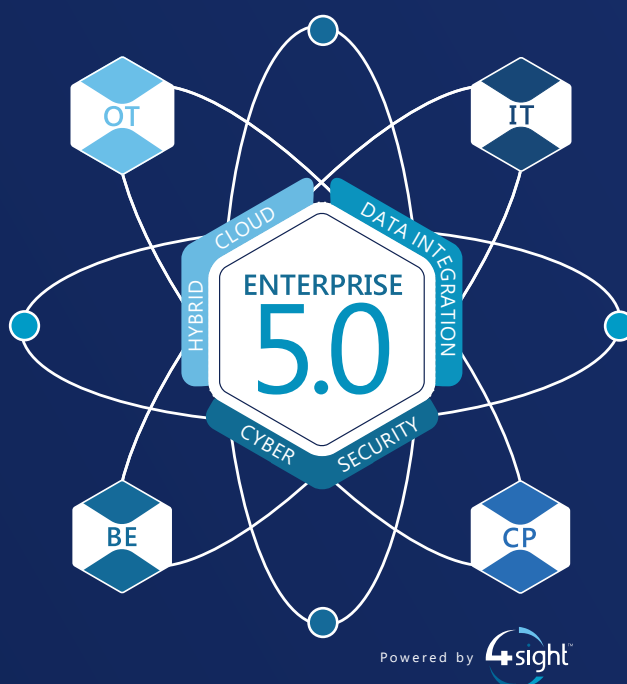
